III. DETAILED COURSE INFORMATION

Teaching Language: English

Course Description

The main goal of the course is to acquire the knowledge and skills necessary to understand the phenomenon of communism. The basic approach of the course will be based on historical sciences, and some results and approaches from other related disciplines, primarily philosophy, sociology, and political science, will also be used. The phenomenon of communism will be analysed from its philosophical origins in the 19th century, through various variations of communist ideologies, movements, and regimes, and the significance of communism in today's world will also be presented. The course will encourage students to independently articulate their views, improve critical thinking, and acquire value-based attitudes towards totalitarian ideologies and their historical articulations.

1. Master the basic problems of interpreting communism as a historical phenomenon; 2. Distinguish processes of individual historical period of communism and themes according to historiographic approaches and research achievements; 3. Critically analyze and interpret sources and literature on the history of communism; 4. Use the contributions of other scientific disciplines in historiographic work and the necessity of an interdisciplinary approach to observing communism as a transnational historical phenomenon; 5. Write a clear and structured paper; 6. Adhere to ethical principles in work.
